

MARTIAL ARTS TV VIDEO RELEASE FORM & GRANT OF RIGHTS

1. Core

By uploading or sending in any Material (footage or moving or still images recorded in an audio visual medium), I hereby grant Martial Arts Networks Ltd ("MATV") an irrevocable, unconditional, world-wide, royalty free licence to use such Material or any part of it in perpetuity in any and all media and in any manner MATV may determine in their sole discretion.

2. Moral Rights

You thereby waive all so-called moral rights or other similar rights in such Material.

3. Use

In consideration of time and resources MATV expends in evaluating the Material submitted to MATV, which is owned or shot by me and or in which I appear, for possible distribution in a form to be determined by MATV, my desire to gain exposure for myself / my footage and or the Material and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, I irrevocably grant to MATV, it's affiliates, licensees, successors and assignees (collectively MATV) the right to use and distribute the Material or any portion or element contained therein in all means and media, whether known or hereinafter devised, throughout the universe, in perpetuity for whatsoever purpose whatsoever. MATV shall have the right to use my appearance (if any) in the Material, and my name, likeness, and biographical information in connection with its use of the Material. Once submitted, I understand the Material will not be returned.

4. No Obligation to Use

I acknowledge that MATV is under no obligation to use the Material. MATV also has not promised nor given any assurances that I will receive any prize or any other compensation if the Material is included in the program or any other Material. Further, I agree that the program may be cut, edited and or added to for any reason and in any manner which MATV may in its sole discretion determine and may, to the extended decided by MATV in it's sole discretion, have sound effects, music, host voiceovers and / or other elements added to the Material, and that MATV may use and modify the Material or any portion or element of it and combine it with other Materials in the Program or any other program.

5. Quitclaim

I hereby release, discharge and hold harmless MATV and any and all other person(s) or entity(ies) from any and all claims whether at law or in equity (including without limitation, injunctive relief) that I may have at any time (whether or not I am aware of any such claim[s]) (i) by reason of any use, exploitation or exercise of any right(s) granted hereunder, and/or (ii) arising from a breach of my representations and warranties hereunder. I acknowledge that I may hereafter discover claims in addition to the ones released in this document, and I hereby release MATV from any such unknown and/or unsuspected claims.

6. Remedies

I acknowledge that, in the event of a breach of this agreement by MATV or any third party, the damage if any, caused to me will not entitle me to seek injunctive or other equitable relief, and I will not have the right to enjoin the production, exhibition, distribution or other exploitation of the Programs or Material.

7. Warranty

I represent and warrant (1) that I am the sole and exclusive owner or shooter of the Material and have the full right and authority to enter into this agreement and to grant the rights herein, (2) that the Material and MATV use of it as authorised herein will not violate or infringe the rights of any party, and (3) that I am not a member of the Screen Actors Guild, the American Federation of Television and Radio Artists, the Directors Guild of America, the Writers Guild of America, or any like theatrical, motion picture or television union or guild.

To the extent I own any rights with respect to the Material, I hereby irrevocably grant to MATV, it's affiliates, licensees, successors and assignees (collectively MATV) the right, license and permission to freely utilize, exploit and distribute the Material in the same manner as Owner granted to MATV with respect to the exploitation of the Material as expressly set forth in the release.

I hereby agree to indemnify and defend MATV against any and all losses, claims, debts, demands, liabilities, attorney's fees and all other damages or costs arising from or related to a breach of any of the above representations or warranties or the falsity of any of the representations or warranties.

8. Jurisdiction

This Release will be governed by and construed under and in accordance with the Law of England and Wales. I hereby consent and agree to the exclusive Jurisdiction of the courts of England and Wales, in connection with any legal action or proceeding arising out of or related to this agreement, the use of the Material, and /or to any rights granted hereunder.

9. Totality

This agreement constitutes the entire understanding between MATV and me, and cannot be modified except in writing signed by MATV and me. Any waiver of any term of this agreement in a particular instance shall not be a waiver of such term for the future.

10. Severability

In the event that any paragraph or provision is determined to be ineffective or is limited in any manner for any reason, all of the other remaining terms and conditions shall remain in full force and effect.
